

BURGUNDY 2024 AT C&B

Welcome to our season of Burgundy releases.

I am hugely excited about the 2024s, which are elegant and fresh. The cooler season has made for a traditional style that will appeal to Burgundy lovers seeking aroma, verve and fresh drinkability. The whites deliver chiselled citrus fruit with an impressive acid backbone – the best will rival the 2014s.

A wet spring and summer hit yields, particularly of Pinot Noir in the Côte de Nuits, where some growers lost 50–90% of their crop. By contrast, the hardier Chardonnay grapes saw near-normal volumes in places, albeit with notable exceptions in Chablis and parts of Puligny-Montrachet. Sustained spells of sunny, breezy weather in August and September kept the vines healthy and brought ripeness over the line.

The 2024s are much more than 'cool vintage' wines. Thanks to today's knowhow, they are wines

of panache that have a place in every Burgundy collection. I hope that those of you who come to our Burgundy tastings in January will agree.

Although most wines in this offer are from the 2024 vintage, some producers release their wines a year later, so are offering the 2023s.

As you will see, many wines are available to order now. The wines of some domaines will be offered separately; please let us know if you would like us to contact you about these in due course.

The 2024 vintage is small, so don't delay. Aside from the allocated wines, we will process orders on a first come first served basis.



CHABLIS

Chablis is unmistakable for its distinctive profile — dry, flinty, mineral, steely — that sets it apart from the classic white Burgundies of the Côte d'Or.

This stylistic difference is perhaps unsurprising, given that the Chablis appellation is geographically separate. Located 130km northwest of Beaune, it is a scenic 1.5-hour drive through the craggy Massif du Morvan. In fact, Chablis might be considered closer to Champagne in terms of its climate and style.

Perhaps the largest contributing factor to the wine's distinguishable characteristics is the soil type. Clay-limestone dating back to the Jurassic period, with undulating chalk, imparts the hallmark minerality.

The appellation comprises a four-level hierarchy: Petit Chablis, Chablis, Premier Cru and Grand Cru. Within the more prestigious categories, 47 individual plots have been identified and named. These climats can appear on the wine label to indicate the unique organoleptic qualities of the liquid inside.

DOMAINE VINCENT DAMPT

Vincent Dampt is the scion of two great winemaking names, Dampt and Defaix, so it is hardly surprising that he would choose wine as his *métier* – or perhaps it chose him! Vincent enrolled himself in wine school in Beaune aged just 14, then worked in Puligny-Montrachet (with Olivier Leflaive) before heading further afield to Marlborough, New Zealand – an experience he calls ‘mind-expanding’. Vincent later returned to Chablis, to the family estate in the hamlet of Milly, to work under the expert tutelage of his father Daniel.

In 2003, Vincent inherited a few small vineyard parcels in Milly, and was able to create his own domaine, adding a few further plots over the years. Vincent and his wife Émilie now manage ten hectares of vines, including those in the *premier crus* of Côte de Léchet, Les Lys and Vaillons: prized sites on pure Kimmeridgian soils – calcareous clays with limestone and marine fossils, held to give Chablis their hallmark minerality.

Rigour in the vineyard is paramount, while his wines are made using the purest juice and only the finest lees. The Dampt style is elegant and pure yet accessible, with the textural delicacy and classic crushed shell profile that define the appellation.

● PETIT CHABLIS

2024 ★

Vincent's Petit Chablis parcels lie high on the plateau above the village of Fyé, on the left bank of the river Serein. Here, altitude, exposure and weathered Portlandian clay soils combine to produce Petit Chablis with a palpable sense of place and poise. The cooler, cloudier 2024 vintage has yielded wines with definition and transparency: gentle citrus notes mingle with apple and pear, lifted by hedgerow scents of mayblossom and cow parsley, a whisper of wet earth beneath. Crisp, cleansing acids define the palate, brightened by crushed-shell freshness and a dry, refreshing finish that feels thoroughly Chablisien.

● CHABLIS

2024 ★

One of our perennial best-sellers, Vincent's Chablis remains a benchmark classic, drawn from vineyards situated primarily between the *premiers crus* of Vaillons and Côte de Léchet. Purity, minerality and typicity are once again the guiding principles, with the pedigree unmistakable. In the cooler 2024 vintage, the wine is finely etched and precise, offering oyster shell, lemon oil and a gently zesty profile. Silky yet incisive, it has a graceful, chiffon-like texture, underpinned by crisp acids and a long, clean line that speaks clearly of its origins.

● CHABLIS 1ER CRU LES VAILLONS

2024 ★

Vincent Dampt farms 0.6 hectares in Vaillons, a *premier cru* formed of a patchwork of micro-terroirs, each lending subtle nuance. Beneath the classic Kimmeridgian limestone sits a generous clay subsoil, lending balance even in more challenging seasons. As ever, Vincent blends fruit from the sunnier Beugnons parcel with the cooler Chatains, near Les Lys, achieving a compelling equilibrium. The 2024 Vaillons is delicately perfumed with white flowers and wisteria, alluring yet restrained. Lithe and balletic on the palate, the wine is silky in texture, held with steely precision, its crushed-shell minerality carrying through to a cleansing, weightless finish.

● **CHABLIS 1ER CRU CÔTE DE LÉCHET**
2024 ★

High on the precipitous slopes of Côte de Léchet, Vincent Dampt's parcels are rooted in stony, nutrient-poor soils on gradients reaching 38%, conditions that naturally favour intensity and definition. With vines ranging from 1974 plantings to more recent, high-density plots, this is a terroir Vincent holds especially close. In the cooler 2024 vintage, Côte de Léchet reveals itself with smoky, stony aromas, layered with crushed shells and iodine. The palate is deep yet contained, the texture fine and chiffon-silk smooth, with impressive length and a sense of quiet, controlled power that unfurls with self-assurance.

● **CHABLIS 1ER CRU LES LYS**
2024 ★

A small parcel atop the tranquil slopes of the Vaillons hillside, Les Lys carries a sense of quiet distinction, often bottled separately to honour its individual character. Its fine Kimmeridgian clay-limestone soils and cool, north-easterly exposure are ideally suited to a vintage like 2024, accentuating finesse and purity. The wine opens with a latent fragrance of oyster shells and white blossom, subtle and elegant. The palate is poised and precise, walking the tightrope of soft chalk and cool stone, filigree-cut. Ethereal and cleansing, the finish lingers long, threaded with the fine chalk-dust minerality of its terroir.



CÔTE DE NUITS

The northern half of the Côte d'Or escarpment, the Côte de Nuits stretches around 30km from Chenôve, on the southern limits of Dijon to Corgoloin, just before the hill of Corton.

Just 200-800m wide, this illustrious region covers 3,600 hectares. From north to south, it encompasses the principal villages of Gevrey-Chambertin, Morey-Saint-Denis, Chambolle-Musigny, Vougeot, Vosne-Romanée, Échézeaux and Nuits-Saint-Georges. The last of these bestows its name on the Côte itself.

The lower slopes of the Côte de Nuits are more fertile, whilst the higher reaches have sparser topsoil and offer less vine vigour. The sweet spot lies on the mid-slopes. Here, you can find an impressive number of *premiers crus*, and the majority of Burgundy's *grands crus*.

Renowned as the epicentre of Pinot Noir, this subregion produces some of the world's most sought-after reds in tiny quantities. Silky, complex and long-lived, they can command high prices with good reason. The whites are not to be overlooked, with a handful of producers making elegant, high-quality Chardonnay.

Simply put, the Côte de Nuits is home to some of the greatest wines in the world.

GEVREY-CHAMBERTIN

For many, Gevrey-Chambertin needs little introduction. Home to some of the world's most iconic reds, it has been a source of prestigious Pinot Noir for centuries — in fact, Gevrey-Chambertin was believed to be Napoleon's favourite wine.

In 1847, Gevrey hyphenated its name to that of its finest vineyard, Chambertin, which was dubbed the 'king of wines and wine of kings' — a phrase that still resonates today.

Stretching across 410 hectares, from Brochon in the north to Morey-Saint-Denis in the south, it is the largest wine producing village within the Côte d'Or. It includes an astonishing nine *grands crus*, more than any other village, which are matched if not surpassed by a handful of *premiers crus*.

The complexity and variety of styles on offer here are owing to the diverse *terroir* and world-renowned winemakers.

DOMAINE JOSEPH ROTY

This tiny estate in the heart of Gevrey-Chambertin makes wines of elegance and richness with an underlying understated power. These wines continue to fly under the radar – which suits their dedicated core of followers just fine...

Joseph Roty was succeeded by his son Philippe in 2008. Following his untimely death in 2015, Philippe's younger brother Pierre-Jean took over, representing the 11th generation. Pierre-Jean's sister Patricia, wife Gwendoline and mother are key members of this family team.

Based in the heart of Gevrey-Chambertin, their vines spread across 8.5 hectares in total. They create gorgeous wines ranging from regional Bourgogne to some of the greatest *grands crus*.

Domaine Joseph Roty releases its wines once they are bottled, so this year's release is of the 2023 vintage. The vintage required severe sorting but the yield was excellent according to Pierre-Jean. He likens 2023 to the 2017 vintage, but “with the power turned up to 10”. The premiers crus saw 50–60% new oak, and 80% for the grands crus.

● BOURGOGNE CÔTE D'OR BLANC 2023

A Bourgogne Blanc with a difference, being 80% Pinot Blanc (planted in 1990) and 20% Chardonnay. It comes from parcels in Gevrey-Chambertin and Marsannay. Fleshy white peach and apricot aromas, leading into a stricter palate with a nice crunch. 18 months in oak, 10% new, including some *demi-muids*. Malolactic takes place in tank, with light *bâtonnage*.

● MARSANNAY ROSÉ 2023

50+ year old vines, with direct pressing and 100% destemmed. Strawberries and vanilla – this is a joy, offering sweetness and volume. Pierre-Jean Roty leaves the juice in the press for 45 minutes' extraction – the time it takes to fill the press. It is then extracted at 0.6 bar and fermented at 22–23°C in a stainless steel tank, with malolactic also in tank. It receives 16 months' ageing, of which 15 months are in one-to-two-year-old oak barrels. “Good with a pizza”, Pierre-Jean recommends, but other pairings are also possible.

● MARSANNAY BLANC 2023

This comes from two parcels in Marsannay: Champs Saint-Étienne (from where Roty is the only domaine to produce a white) and Les Boivin. Zesty, crunchy and mineral, this offers bright white flowers and is full of energy. Wet stone minerality, then bitter and pithy on the finish. 20% new oak, with some larger *demi-muids*, with malolactic fermentation in tank.

● COTEAUX BOURGUIGNONS 2023

The Coteaux Bourguignons appellation dates from 2011, replacing Bourgogne Grand Ordinaire. Although Gamay is permitted, this domaine's wine has always been 100% Pinot Noir. The vines are nearly 40 years old, a massal selection from family holdings. This parcel is just below the Gevrey-Chambertin boundary, planted by Pierre-Jean's father Joseph. This is all about the joyful Pinot Noir fruit, which here is juicy and tender, finding a crunch and definition on the end. *Élevage* in two-year-old oak barrels.

● BOURGOGNE CÔTE D'OR ROUGE

2023

Although labelled Bourgogne Rouge, this is declassified Marsannay. It comes from two free-draining, warm parcels, 40-60+ years of age: Champ Forey to the north and Leautier to the south. Brightly red-berried, crunchy and acid-driven, this is a classical style of Bourgogne Rouge, for early drinking. Great purity. No new oak.

● CÔTE DE NUITS VILLAGE

“LA CROIX VIOLETTE”

2023

This is the second vintage of this new wine. La Croix Violette is spread over two plots, totalling 0.33 hectares in Brochon, just behind the Château de Brochon, which you can see from the domaine. These are 70-year-old vines. One plot is more clay-rich, while the other is on the limestone bedrock. This will be in the Fixin appellation from 2024. Rich, imposing raspberry coulis, which makes the balancing acidity work. Fabulous, with lushly fruit-coated tannins providing support. 60% new oak.

● BOURGOGNE CÔTE D'OR
CUVÉE DE PRESSONNIER

2023

A nearly-Gevrey-Chambertin: this 1.5ha parcel was within the appellation boundary until 1964. It lies across the Route Nationale from Clos Prieur-Bas. The oldest vines here date from 1925, with the youngest having been planted in 2012. Darker and sweeter on the nose – richer and more ‘Gevrey’. The palate is inky dark and impressively intense, with real tannic presence and a nice serenity to the dark berry fruit. A serious wine, bravo. No new oak.

● MARSANNAY ROUGE

2023

This is a blend of five parcels, comprising the domaine's Marsannay *lieux-dits* other than Champs Saint-Étienne (see top right): Quartier, Ronsoy, Favières, Rosey (Charmes aux Prêtres) and Bas de Longeroies. The vines are 50 years old on average. It should become a *premier cru* once the long-awaited reclassification of Marsannay happens. Intense ruby colour. Bright raspberries and rhubarb on the nose, leading into a palate of crunchy red berries and savoury leafiness, framed by fine, currently-grippy tannins. The acidity is bright, almost piercing at this early stage. 40% new oak. 18 months in barrel.

● MARSANNAY ROUGE CHAMPS
SAINT-ÉTIENNE

2023

The domaine has 18 *ouvrées* (around 0.75 hectares) of Marsannay, 14 *ouvrées* of which are planted with Pinot Noir. The vines are over 50 years old. This is a mid-slope site, consisting of two parcels. The Rotys are the only domaine to bottle Champs Saint-Étienne as a separate *cuvée*. Lovely bright raspberry and intense, plush wild strawberry fruit here, with that same crunchy, tensile line of acidity. Super wine. 50% new oak.

● GEVREY-CHAMBERTIN

2023

The domaine's Gevrey village is a blend of four parcels, accounting for just over a hectare in total. Dark berry aromas with blood orange zest, powdered cacao and cedar spice. The palate is supple and inviting on the entry, opening onto a mid-palate of seamless blackberry fruit framed by fine, chalky tannins. The transition from the previous wines to Gevrey is marked by an added finesse. 50% new oak.

● **GEVREY-CHAMBERTIN
CUVÉE LA JUSTICE**
2023

These are free-draining sandy and loamy soils, in the centre of La Justice, which Pierre-Jean has worked with biodynamic preparations. 40-year-old vines. The first vintage was 2022. Pretty blueberry and violet aromas, leading into a palate of fresh blackberry fruit and dried spices. Light on its feet, nimble, with especially soft, melting tannins which Pierre-Jean attributes to the sandy, readily draining soils. Five barrels. 60% new oak.

● **GEVREY-CHAMBERTIN
CUVÉE DE LA BRUNELLE**
2023

Planted by Pierre-Jean's father and grandfather in 1960, La Brunelle is directly behind the domaine buildings, a walled vineyard in the centre of the town of Gevrey-Chambertin. Alluvial, clay-rich soils. This is a tiny parcel of just four *ouvrées* (0.17ha). Dark berries, nutmeg and cedar on the nose, with an emerging aromatic finesse. The richly dark-fruited palate is pliant and cushioned, offset against a fine line of driving acidity. Dried spices on the finish. Joe Muller's excitement at tasting this prompted Pierre-Jean to rechristen it "Cuvée Bloody Good."

● **GEVREY-CHAMBERTIN 1ER CRU
LES FONTENYS**
2023

This comes from the heart of Fontenys, which lies within a warm hollow. The domaine has half a hectare here, which is usually picked on the first day of harvest. The name Fontenys alludes to a 'little fountain' and the subterranean water sources. This is one of the estate's most complex *terroirs*, according to Pierre-Jean, with alluvial, limestone and clay soils. Sweetly, darkly fruited on the nose, this is immediately inviting — blackberries and cream. The palate has a core of dark, rocky minerality around which unwind flavours of bitter cherry, cassis and blackberry, lifted by poised acidity. Menthol and dried spices on the finish.

● **MAZY-CHAMBERTIN GRAND CRU**
2023

Sometimes spelt 'Mazis', the Roty's holding in Mazy-Chambertin is adjacent to Domaine Dugat-Py's. A section of these vines was planted in 1919. Bright raspberry aromas — "this makes you smile", as Joe Muller said. Fabulous purity here. This is a wine of small, intricate, sweet red berries which build in a crescendo of volume and flavour. The crest of the wave is something else... Filigree fine fruit definition which builds to "something serious". In Pierre-Jean's words, "Mazy tends to be **massive**. Juste comme il faut." 100% new oak.

● **GEVREY-CHAMBERTIN
CHAMPS CHENYS**
2023

This is a blend of five parcels across Champs Chenys, which is directly below Charmes-Chambertin. The oldest vines here were planted in 1934 and are ungrafted, on their own roots. Soaring violet and rose aromas. The palate has something of that weightless *aérien* quality, finding a pretty raspberry-fruited elegance on the mid-palate. Fennel seed, according to Joe Muller... Very good.

● **GEVREY-CHAMBERTIN
CLOS PRIEUR BAS**
2023

Clos Prieur Bas is planted on similar soil to Charmes-Chambertin — clay and Bajocian limestone. Four *ouvrées* (0.17ha) — the same size as La Brunelle. The higher part of this vineyard, Clos Prieur Haut, is a *premier cru*. This lower section has deeper soils. Sweet, creamy dark berry aromas, leading into a palate of pliant, rich blackberry and raspberry fruit, with a frisson of chalky limestone minerality, framed by lavishly fruit-coated tannins. This finishes salty and precise. 60% new oak.

Dark berries and raspberry coulis on the nose, bright and ripe, with delicate dried violet aromas. The palate is almost painfully intense, yet so light on its feet at the same time — fresh and vivacious, with a punch of sweet red berry concentration.

DOMAINE ROSSIGNOL-TRAPET

The marriage of Jacques Rossignol and Mado Trapet unified two winemaking families – the Rossignols of Volnay and the Trapets of Gevrey-Chambertin. For many years, they worked together at Domaine Louis Trapet until their two sons, David and Nicolas Rossignol, returned from their studies. At this point, the Trapet family holdings were divided. Jacques and Mado established Domaine Rossignol-Trapet in 1990, subsequently handing over to David and Nicolas.

In 2005, conversion to biodynamic viticulture began, with organic and biodynamic certifications obtained in 2008. The cellar, which is partly subterranean, was built in 1983. A row of lights around the cellar walls indicates ground level. The water table lies almost immediately beneath it, ensuring a high level of natural humidity.

● BEAUNE 1ER CRU LES TEURONS

2024

This 1.2-hectare plot, planted in 1978, is on the high part of Teurons, close to the woods and beside Aux Cras. This is a stony, iron-rich red soil. The cliff at the top of the slope reflects the sun and, along with the trees, protects the vines, making for early ripening. Fine, dark, minerally aromas, leading into a palate of seamless blackberry fruit and supple, fine tannins, lifted by poised acidity. 10% new oak, 100% destemmed. This will be bottled at the end of January 2026, as usual.

Petite Chapelle is just beneath Clos de Bèze. It has a 1.5-2m layer of topsoil with rich clay beneath. This is a half-hectare holding, straddling both lieux-dits of Petite Chapelle. Aromas of blackberry and a hint of raspberry compote. The palate is the most structured yet, the substantial berry fruit balanced against fresh acidity and framed by firm, chalky, fruit-coated tannins. 100% destemmed, with 25% new oak.

DOMAINE DU COUVENT

Domaine du Couvent is situated in the heart of Nuits-Saint-Georges, within a century-old building that houses deep and cavernous cellars directly beneath. Encompassing ten hectares of vineyards spread across the Côte de Nuits, father and son team Philippe and Paul Chéron run the estate.

The domaine was formed by the union of Domaine des Varoilles and Domaine Misset-Chéron. The wines of Domaine des Varoilles, which now form part of the Couvent range, will be familiar to longstanding C&B customers. Domaine Misset-Chéron was established in the late 1930s by Philippe's grandfather, Paul Misset, when he acquired a plot of Clos de Vougeot. Domaine des Varoilles was bought in 1964 by the Chéron family in conjunction with the Naigeon family, vigneron from Gevrey-Chambertin.

Today, Philippe and Paul approach their wines with passion, *terroir* expression, and respect for sustainability in the vineyards, producing wines that are pure, precise and full of personality.

As well as offering the wines in the UK, Corney & Barrow is the exclusive agent in Hong Kong, Singapore & China.

● MARSANNAY BLANC LES LONGEROIES

2024

This comes from a 0.35-hectare parcel. 2021 was the first vintage. East-facing vines are planted in long rows (250m), with a slight slope. The soils are a combination of pebbles, silt and Bresse marls. Aromas of pure white peach and apple skin, with pithy grapefruit. Fabulous purity on the palate, with bright, joyful freshness and high, integrated acidity. No crushing and no sulphur at pressing. This settles for 24 hours, is fermented in stainless steel tank and then racked into oak barrels for 18 months with no lees stirring. Lightly fined before bottling. Just 7hl/ha in 2024. One 500L barrel and the rest in stainless steel tank.

This one-hectare vineyard is a *monopole*, owned in its entirety by the domaine. It has similar stony soils to the adjacent 1^{er} Cru Champonnets, relatively deep and with gravel. Half the vines are over 60 years old, whilst the rest were planted in the 1990s. Philippe described this as “a joyous site and wine”. Aromas of blueberry, peony and fresh mint. The palate is sappy and linear on the entry, opening onto a tactile mid-palate whose fine berry fruit is framed by quite firm tannins. Good ageing potential. 50% whole-bunch fermentation. Eight barrels in 2024 – a decent volume. 15% new oak.

It has 50cm of soil, with a gravel and limestone bedrock, making for a naturally low-yielding site. Pure, dark forest fruit aromas, with blueberry and damson. The palate is spherical and bright, darkly berried, with tactile limestone energy from the mid-palate through to the finish. Seven barrels, of which one was new. 100% destemmed.

More structured than Les Quarantes Ouvrées, with greater ageing potential. Four barrels were made.

Made since the 2021 vintage. This 0.42-hectare site runs from the southern side of Chambolle-Musigny to the *premiers crus* Charmes, Les Grands Murs and Chatelots. The vines were planted in the 1970s. The name Feusselette is derived from the word 'Feusse', or 'hollow', referencing the vineyard's topography. The soils are shallow, with compact, rich Comblanchien limestone and marl. This was acquired from La Pousse d'Or, in exchange for some Charmes. Bright, saturated raspberry fruit and a juicy, fleshy aspect to the palate. Expressive fruit meets a tightly packed structure that needs time to meld. 100% destemmed. Seven barrels in 2024 – this was surprisingly generous, with large berries.

A very pretty rendition of Vougeot on the nose, leading into a palate of tactile dark berry fruit, with firm grip which will soften during *élevage*. Four barrels, of which one was new, so 25% new oak. Almost no press juice.

DOMAINE TRAPET

Family-run Domaine Trapet in Gevrey-Chambertin is thriving, with the next generation firmly in place, in the shape of Jean-Louis and André Trapet's sons, Pierre and Louis.

The domaine's holdings are about as good as it gets in and around Gevrey-Chambertin. Delve below the *grands* and *premiers crus* to find the beating heart of this biodynamic estate: village Gevrey and Marsannay of luminescent fruit and soaring perfume.

The Trapet wines exude effortless elegance born of a labour-intensive approach. A growing proportion of the vines are trellised on single poles, known as *échalas*. 50,000 of these posts have been installed in recent years, at an average density of 12,500 vines per hectare. As Louis Trapet says, this method ensures nutrients are channelled into the berries rather than the leaves. You also tend to get 0.5% abv less alcohol with the *échalas*. Other onerous techniques include removing the central stem from each bunch to avoid extracting the more astringent phenolic components.

The wines of Domaine Trapet are released once bottled, meaning the 2023 vintage will be out in early 2026.

DOMAINE DUGAT-PY

The Dugat family have been growers in Gevrey-Chambertin since the early 17th century. Current incumbent Loïc Dugat represents the 13th generation and has reinvigorated the domaine's viticulture and cellar work.

The 15-hectare estate boasts what the labels term *très vieilles vignes* – the average vine age here is over 70 years, but some are well over a century. The historic cellar is the only remaining part of a 9th century abbey – gothic vaults and Byzantine style with an impressive six-metre height.

The domaine has been organic since 2008. Since his arrival, Loïc has also embarked on a renewed path of detail-focussed viticulture following the lunar cycle, and sensitive cellar management using very selective oak.

MOREY-SAINT-DENIS

The second-smallest village of the Côte de Nuits, Morey-Saint-Denis, is often overshadowed by its more famous neighbours: Gevrey-Chambertin to the north and Chambolle-Musigny to the south. Geologically, it shares similarities with both villages: a stratum of limestone runs through all three appellations.

Morey-Saint-Denis boasts four *grands crus*: Clos des Lambrays, Clos de la Roche, Clos Saint-Denis and Clos de Tart, with a fifth *grand cru* overlapping from Chambolle: Bonnes Mares.

The self-contained nature of this village is echoed in the abundance of walled vineyards – all adding to the charm and individuality of this place.

DOMAINE PERROT-MINOT

We have worked with Christophe Perrot-Minot since the 2016 vintage and are now proud to be his exclusive agent in the UK, Singapore and China. The domaine is based in Morey-Saint-Denis, although the range also covers Gevrey-Chambertin, Chambolle-Musigny, Vosne-Romanée and Nuits-Saint-Georges. The estate, which extends to 12.5 hectares, is an amalgam of two sources.

The original holdings, inherited from Christophe's maternal grandfather, were bolstered significantly by the acquisition of Domaine Pernin-Rossin in 2000.

Winemaking techniques include a degree of whole-bunch vinification, which brings fresh sapidity to the wines, whilst never dominating the flavour profile, allowing these great terroirs to shine through. New oak use is similarly moderate, with a maximum today of 20%. Christophe took charge of the domaine in 1993 and has progressively implemented stylistic changes in the pursuit of elegance and finesse.

● BOURGOGNE ROUGE

2024 ★ 🍃

This is a blend of two sites: Chaponnières, in Morey-Saint-Denis and Gravonnières, in Chambolle-Musigny. Bright raspberry and red cherry aromas. The palate is crunchy and fresh, sustained by bright acidity. 8-10% whole-bunch fermentation, which is the case for all the wines in 2024. A crisp-fruited early drinker.

DOMAINE DU CLOS DE TART


The walled vineyard of Clos de Tart is situated at the very heart of Morey-Saint-Denis. It represents one of four *grands crus* within the village and is a *monopole*, under sole ownership. Its sloping 7.53 hectares overlook the village. Created in 1141, Clos de Tart was owned by the Bernardines de Tart (an order of Cistercian nuns), the Marey-Monge family (post-French Revolution) and then the Mommessin family from 1932.

At the end of 2017, the Clos was acquired by François Pinault's Artemis Domaines. Clos de Tart is one of only seven *grands crus* monopoles in France, five of which are in Burgundy (the other Burgundian vineyards being Romanée-Conti, La Tâche, La Romanée and La Grande Rue).

The wines of Clos de Tart are now released once bottled, meaning the 2023 vintage will be released in **spring 2026**.

CHAMBOLE-MUSIGNY

Snug against the limestone cliff faces and somewhat isolated from the rest of the Côte, there is something magical about Chambolle-Musigny. The red wines hailing from here offer rich and velvety elegance, combining soaring perfume and tannic structure.

Chambolle-Musigny has two *grands crus* vineyards, Musigny and Bonnes Mares, at the southern and northern extremes of the village respectively, and a *premier cru* worthy of being promoted: Les Amoureuses.

The east-facing slopes lie at 250-300 metres based on Jurassic limestone and benefit from excellent free-draining gravel soils descending towards the valley floor.



FRANÇOIS MILLET & FILS

François Millet is considered a legend in the village of Chambolle-Musigny. He has made wine here since 1986, over 30 years of which were at Domaine Comte Georges de Vogüé.

He established François Millet et Fils with his wife Michelle and two sons, Julien and Adrien, in 2016. Grapes are bought from five or six domaines across the Côte d'Or and Côte Chalonnaise. Working closely with the growers, François monitors the vines throughout the year and agrees with each domaine when to harvest.

He categorises his wines as either 'mineral' or 'structural', using descriptors so considered and evocative that it brings their personalities to three-dimensional life. As these wines are from the **2023 vintage**, they are already bottled with expected shipment in early 2026.

● BOURGOGNE ALIGOTÉ LES GRAVIERS

As François said about this wine, "The idea is to get away from the variety and closer to the place". Les Graviers comes from vines adjacent to those of Les Rues (the Bourgogne Rouge), just opposite the village of Chambolle-Musigny. Apple skin and white flower aromas, with a crunchy palate of citric freshness.

● BOURGOGNE ROUGE LES RUES

Les Rues sits at the bottom of the village of Chambolle-Musigny, on the other side of the Route Nationale. The stones are very important here, making for excellent drainage. "A sort of Petit Chambolle", according to François. Pretty raspberry fruit and, yes, Chambolle-like aromas of roses. Blood orange and tangerine on the palate, balancing out the fleshy raspberry fruit from the heavy clay soils. Very good.

● FIXIN EN L'OLIVIER

Fixin, at the northern end of the Côte de Nuits, is a rising star in Burgundy, in part thanks to its vein of limestone, which is perhaps its main differentiating factor from the clay and marl of Marsannay. En l'Olivier, the name coming from olive tree, is at the same level on the slope as the two *premiers crus* of Fixin. Mint and clipped red cherry and raspberry fruit. Ripe, and then a bite of mineral grip. Or as François put it, "A flow of minerality – there's something swift, like a river about this minerality." Julien said, "This is structural and mineral, quite complete." The grapes here tend to be thin-skinned.



A small village in the Côte de Nuits producing Pinot Noir and small amounts of Chardonnay.

The most significant vineyard in Vougeot is the Grand Cru Clos de Vougeot – a 50-hectare enclosed plot that was originally planted by Cistercian monks. From the beginning, this special vineyard was noted for its varying *terroir*: the top contains light calcareous and gravelly soil over limestone, the middle section reveals softer limestone with clay and a smattering of gravel, while the bottom is almost flat and consists of poorly drained alluvial clay. The monks typically blended across these sites to make their wines, whereas today, Clos de Vougeot is fragmented between 80 or more owners, who make varying styles.

This clos isn't the only place to find excellent reds, however. Vougeot can be a source of extremely long-lived Pinot Noirs and excellent Chardonnays, which, in combination with deft winemaking and increasing use of stems, can also display great elegance. Perhaps here more than anywhere else in Burgundy, 'grower is everything'.

CHÂTEAU DE LA TOUR

Château de la Tour was established in 1890 and owned by the Labet family. It is the largest property of the Clos de Vougeot, encompassing 5.5 hectares, representing 12% of the total appellation.

The family's holdings comprise essentially two parcels, one close to the château itself, with another smaller holding higher on the slope, bordering Les Échézeaux. The vines have an average age of 70 years, with a one-hectare plot planted in 1910 at their heart. Yields are controlled by 'rubbing out' every second bud to give a well-aerated canopy. The domaine has been organic since 1992.

Today, the estate is run by François Labet and his son Édouard. Their approach to winemaking includes whole clusters for Pinot Noir and early picking for Chardonnay. Immediate racking for reds once fermentation is complete is employed to avoid astringency in the juice.

In addition to Château de la Tour, François and Édouard own holdings in the Côte de Beaune. These wines are bottled under the label Domaine Pierre Labet. Winemaking takes place in their operational building in Beaune, but *élevage* is completed in Château de la Tour's cellars. For more details, see page 38.



DOMAINE DE LA ROMANÉE-CONTI

Located in the wonderfully named Rue du Temps Perdu, Domaine de la Romanée-Conti is a Burgundy institution. The Domaine's co-directors are Bertrand de Villaine, nephew of Aubert de Villaine, and Perrine Fenal, daughter of Lalou Bize-Leroy.

There are nine *grands crus* vineyards. In addition, a Vosne-Romanée 1^{er} Cru is released in some years, made from voluntarily declassified grapes. The red *grands crus* are Corton, Échézeaux, Grands Échézeaux, Romanée-Saint-Vivant, Richebourg and two 'monopoles', solely owned by the Domaine – La Tâche and Romanée-Conti. The white *grands crus* are Corton-Charlemagne and Montrachet.

Following the confiscation of the vineyards of the Prince de Conti during the French Revolution, the domaine was acquired by Monsieur Duvault-Blochet in 1869. La Tâche was bought in 1933. Romanée-Saint-Vivant was managed from 1966 and purchased outright in 1988. In addition to owning the vineyards of Romanée-Conti and La Tâche in their entirety, the domaine owns half of Richebourg, over half of Romanée-Saint-Vivant, a third of Grands Échézeaux and a seventh of Échézeaux.

Corton-Charlemagne was added to the line-up in the 2019 vintage. Made from vines leased from Domaine Bonneau du Martray, it sits alongside the red Corton, which has been produced since the 2009 vintage.



NUITS-SAINTE-GEORGES

A small Burgundian market town with huge vinous significance, Nuits-Saint-Georges is the southernmost appellation of the Côte de Nuits. Home to the famous 'wine brotherhood', the *Confrérie des Chevaliers du Tastevin*, it is also the town from which the Côte de Nuits takes its name.

Covering a substantial 300 hectares of vines, Nuits-Saint-Georges has extremely varied soils and aspects. Perhaps surprisingly, there are no *grands crus* within this appellation, but it does boast an impressive 41 *premiers crus*.

Pinot Noir dominates here with three approximate divisions in wine style: in the north (nearing Vosne), the reds offer elegance with a hedonistic richness; in the heartland of the appellation, just south of the town, the wines are full, with depth of colour and tannic structure; the furthest south, you can find the lighter and more delicate styles. There are just seven hectares dedicated to white wine production.

DOMAINE DE L'ARLOT

Domaine de l'Arlot is a 14-hectare property in the commune of Prémeaux, just south of the famed town of Nuits-Saint-Georges.

At the end of the 18th century, Jean-Charles Vienot inherited a domaine in the small village of Prémeaux, handed down through a long line of his ancestors. During his time here, Jean-Charles built a wall around the property and its vines, creating what would become Clos de l'Arlot, which today is a Nuits-Saint-Georges *premier cru*.

AXA Millésimes, the wine division of the insurance company, has owned the domaine since 1987. Since 2014, the wines have been made by Technical Director Géraldine Godot.

● NUITS-SAINT-GEORGES BLANC 1ER CRU CLOS DE L'ARLOT MONOPOLE 2024

There are two hectares of Chardonnay planted in Clos de l'Arlot, the domaine's iconic, steeply sloping amphitheatre. The pink Prémeaux limestone contributes to this wine's exuberant, broad, long-ageing character. White peach and candied citrus fruit aromas lead into a crunchy, phenolic palate of lemony acidity and sherbet. Bright and clipped with a zesty, white flower finish. Tasted from tank, where it had been since the end of August 2024, before bentonite fining and filtration. Bottled at the end of December 2025. The yield here was a tiny 13hl/ha.

This is the southern end of the Côte de Nuits, whose quarries offer glimpses of the limestone beneath. Very pale ruby colour. Pretty aromas of peonies, violets and roses. The palate opens crunchy and precise, remaining puckeringly driven, lifting the flavours of fine raspberries. Tasted from bottle, Clos du Chapeau having been bottled in August 2025, just before the harvest, as usual. Harvested on 19th September 2024, on the second of the four-day harvest. 100% destemmed.

Clos de l'Arlot is the emblematic vineyard of the estate, adjacent to the domaine buildings and just north of Domaine Mugnier's Clos de la Maréchale, in Prémeaux-Prissey. There are two hectares of Pinot Noir grapes here, alongside the two of white, planted on marl and free-draining pink limestone. In 2024, the yield here was just 10hl/ha, which included the grapes usually destined for Mont des Oiseaux, the younger vines *cuvée*. Aromas of cedar spices, violets and raspberries. The palate is dark-fruited and precise on the entry, with bracing acidity sustaining the pretty Pinot flavours, framed by fruit-coated, lattice-like tannins. 100% destemmed with 40% new oak. Just nine barrels were made.

CLOS DES FORÊTS SAINT-GEORGES

Clos des Forêts Saint-Georges is a 7.2-hectare *monopole*, owned entirely by Domaine de l'Arlot. Whilst Clos de l'Arlot is in Prêmeaux, this is the centre of the Nuits-Saint-Georges appellation, further north, with more clay-based soils. It tends to be more immediately expressive than the ephemeral style of Prêmeaux. Pale ruby colour. Initially shy in the glass, but with time, aromas of rose and dark spicy berries emerge. The palate has the recognisable structure and body of Clos des Forêts, the darker blueberry and Christmas cake flavours, all couched in a fine, very delicate tannic chassis. 100% destemmed. The yield here was a paltry 3hl/ha. Just nine barrels were made.




The domaine has 0.85 hectares of Suchots, just opposite Domaine de la Romanée-Conti's plot of Richebourg. Taffeta-like rose and raspberry aromas, with cedar spices. The palate is discreet and fine, quite closed at present but slowly releasing aroma into the mouth, framed by fine tannins. The yield was 13hl/ha. Five barrels were made. 100% destemmed.

CÔTE DE BEAUNE

Forming the southern half of the Côte d'Or, the Côte de Beaune is picturesque and feels more rural. Owing its name to the city of Beaune, it is almost twice the size of the Côte de Nuits, with around 6,000 hectares under vine.

The Côte de Beaune is home to Burgundy's greatest white wine villages, including Corton-Charlemagne, Meursault, Puligny-Montrachet and Chassagne-Montrachet. Almost all of Burgundy's white *grands crus* can be found here. This is home to some of the most exceptional Chardonnay in the world.

High quality Pinot Noir can also be found throughout the Côte de Beaune, particularly in Corton, Volnay, Pommard and Beaune.

The majority of *premiers* and *grands crus* vineyards sit at an elevation of 250-300 metres above sea level. Here, clay soils tend to enjoy stony topsoil which aids drainage. Towards the top of these slopes, a narrow band of regional appellation vineyards produces fine, lighter styles of wine, typically labelled as Bourgogne Hautes-Côtes de Beaune.



The vinous capital of Burgundy, Beaune, takes centre stage during the annual Hospices de Beaune wine auction. Confusingly, the city of Beaune shares its name with the large appellation surrounding it, as well as the wider Côte de Beaune. Historically, this area was dominated by large *négociant* houses, which are still based in the city today.

Red wine production dominates here, often stylistically lighter and supple compared to other Côte d'Or villages, owing to its sandier soils — these wines offer a great introduction to Burgundy and the opportunity to enjoy earlier-drinking reds. Beaune also has the good fortune to encompass an unusually high proportion of *premiers crus* vineyards, which make up nearly three-quarters of the appellation.

DOMAINE PIERRE LABET

The Labet family holdings span both côtes. Their property Château de la Tour in Clos de Vougeot was established in 1890 and is today in the hands of François Labet and his son Édouard.

In addition, the father-and-son duo owns land in Beaune, Meursault and Gevrey-Chambertin. The origin of these family holdings dates back to the 15th century and focusses on Côte d'Or premiers crus and village-level selections. These wines are bottled under the name Domaine Pierre Labet.

With an operational base in Beaune, François Labet assumed estate management in 1984 and is recognised as one of the pioneers of organic viticulture in Burgundy. He has been the president of the Vins de Bourgogne Wine Board (BIVB) since 2015 and was awarded the Légion d'honneur in 2019 for nearly 40 years of service to the region.

The Labet family approach involves a high proportion of whole-bunch vinification of Pinot Noir, relatively early picking of Chardonnay and long *élevage* in barrel, which takes place in Château de la Tour's cellars. The highly regarded Sylvain Pataille is the family's longstanding consultant winemaker.

● BOURGOGNE CHARDONNAY VIEILLES VIGNES 2024 ★ 🍃

The domaine's whites are acidity-focussed, the goal being to pick Chardonnay grapes with a sense of freshness. François and Édouard's Bourgogne Chardonnay comes from the Côte d'Or, from two plots in Chorey-Lès-Beaune and Beaune. A reductive nose leading into a palate of zesty citrus fruit, with good purity and chalky mineral texture, the fresh acidity working nicely beside the flinty minerality. Good focus to the finish. *Élevage* in large 350-litre barrels.

It was replanted in 2019 using massal selection and drought-resistant rootstocks. These are therefore young vines, planted on limestone-rich marl soils, with iron and clay. Lime zest and stony minerality on the nose, leading into a flamboyant palate of aromatic white peach and jasmine, with some apricot and honeysuckle. You can feel these are young vines. Finishes nicely textured and focussed. Vinified and aged in a mixture of large 350- and 450-litre barrels.

DOMAINE JEAN-BAPTISTE BOUDIER

Domaine Jean-Baptiste Boudier is a recent name in Pernand-Vergelesses, Jean-Baptiste having started in 2015, before taking over the family domaine completely in 2017. He has recently moved into a brand new winemaking facility, in a beautiful bucolic setting near the village.

This is a domaine on the up, the wines coming from 6.5 hectares of vines on and around the hill of Corton. Jean-Baptiste's holdings are in Aloxe-Corton, Pernand-Vergelesses and Savigny-lès-Beaune. The range covers *village* and *premier cru* quality levels. Two *grands crus* top the line-up: a Corton-Renardes and a Corton-Charlemagne 'Le Corton'.

This one-hectare vineyard is over 80 years old and faces south-southwest. Planted in 1942, these are the oldest vines of the domaine. CORTON & CORTON-CHARLEMAGNE

Corton is the only *grand cru* appellation in the Côte de Beaune devoted to red wine. Located on the hill of Corton and encircled by renowned winegrowing villages, its vineyards form a natural amphitheatre unlike any other in the Côte. Growers may affix the name of a specific *lieu-dit* (such as Corton-Bressandes or Corton Clos du Roi), or they can make a generic Corton from a blend of vineyards. There is also a tiny amount of white wine made here too, but only the red wines can hyphenate to include the name of their *climat*.

Corton-Charlemagne is reserved for *grand cru* whites. This appellation encompasses Le Charlemagne and En Charlemagne vineyards that sit in a narrow band around the top of the hill, descending to the western edge of the hillside. The vines grow on lighter, stonier soils, which are thought to impart a gunflint character to the wines.

DOMAINE BONNEAU DU MARTRAY

Look at the hill of Corton from the south and you will, essentially, be looking at the Bonneau du Martray estate. With 11 hectares in one block located in the southwestern part of the hill in the *climats* En Charlemagne and Le Charlemagne, this is the largest single vineyard holding in Pernand-Vergelesses. It is the same piece of land which was given to the Abbey of Saulieu by Emperor Charlemagne in 775 AD.

In January 2017, Domaine Bonneau du Martray was acquired by U.S. businessman E. Stanley Kroenke, making him only the fifth owner in its 1200+ year history. Mr Kroenke's management team comprises Armand de Maigret and Thibault Jacquet, who spend their time between California – home of Screaming Eagle, The Hilt and Jonata estates – and Burgundy.

In November 2018, Bonneau du Martray leased 2.8 of the domaine's 9.5 hectares of Corton-Charlemagne to Domaine de la Romanée-Conti.

Domaine Bonneau du Martray makes just two wines, both *grand cru*: Charlemagne (white) and Corton (red).

SAVIGNY-LÈS-BEAUNE

Just north of Burgundy's epicentre, Beaune, Savigny-lès-Beaune is celebrated for its intricate *terroir*. The hilly landscape offers a mosaic of soil types and microclimates, resulting in subtle distinctions in the wines made from specific *climats*. These vineyards have ancient lineage, having mostly belonged to the Dukes of Burgundy.

The village itself is divided by the River Rhoin. Vineyards south of the river, such as Les Peuillets, Les Narbantons, Les Rouvrettes and Les Marconnets, are on sandy soils and produce lighter-styled wines. On the northern side, towards Pernand-Vergelesses, plots such as Les Lavières and Les Vergelesses are on stonier soils.

Although the appellation produces both red and white wines, the majority of plantings are Pinot Noir.

Le Puy de l'Ours was established in 2019 by Juliette Puyperoux and Jean Orsoni in Savigny-lès-Beaune. Combining their surnames, they have created something that is both new and evokes a fantastical world of legend.

Jean's roots are in farming in Corsica, while Juliette's heritage is in Burgundy, where a small estate has been in her family for 200 years. Her grandparents continued winemaking until 2004, when they sold their business, but retained the vineyards and winemaking facilities which were rented out. In 2019, Juliette and Jean reclaimed this 3.5-hectare vineyard.

Their first vintage was the notoriously tricky 2021 and was tiny in volume. Since then, Juliette and Jean have expanded their vineyard holdings to the current 7.5 hectares.

Their approach to wine is clearly born of passion and humility with their love for the arts interwoven into every bottle. Their wine labels are inspired by art and literature.

2024 saw a crop loss of 40% overall, with an 80% reduction in reds. Commenting on the 2024 vintage, the couple noted, "What we didn't expect was having something very complete in terms of phenolic maturity". The whites, in particular, have this hallmark phenolic character coupled with acidity similar to the 2021 vintage. The completeness of these wines means they will be approachable in their youth.

● CÔTE DE BEAUNE BLANC LES MONSNIÈRES

2024 ★ 🍃

Monsnières comes from 1.49 hectares of Chardonnay vines on the west-facing high slopes of the Montagne de Beaune, at 350m elevation. Half of these vines date from 1992 and the other half from 2015. Zesty orange blossom and honey aromas, with fresh mint leaves. The palate is crunchy and acid-driven, taut and nervy, with a tactile bite. This started its fermentation in stainless steel tank and finished in barrels, being racked after alcoholic fermentation was one-third complete. Full malolactic in barrel (50% pièces and 50% 300- to 400-litre barrels) and 11 months' ageing, with occasional bâtonnage. 20% new oak. No filtration.

● SAVIGNY-LÈS-BEAUNE BLANC LES GOUDELETTES

2024 ★ 🍃

Les Goudelettes is a 0.33-hectare plot in the hills to the north of the village of Savigny, planted in 1990. Vibrant yellow colour. Aromas of white flowers and blanched almonds. The palate is delectable and buoyant, offering white peach fruit sustained by a high line of lemony acidity. Full malolactic conversion in barrel followed by 12 months' ageing in 300-litre barrels with minimal stirring, then two months in tank before bottling. No new oak, no filtration, no fining.

● L'ABSURDE BLANC DE NOIRS

This is a white wine made from 100% Pinot Noir grapes. Soil expert Claude Bourguignon advised that this white marl terroir would work well for whites. It comes from 0.24 hectares in Clos des Godeaux, the same vineyard as the first of the reds, planted in 1968. Aromas of nettles and white pepper, leading into a palate of grapefruit, fine white peach and pear fruit. Grapey, with tactile phenolics. Partial malolactic fermentation is followed by 10 months' ageing in old oak barrels, with occasional lees stirring. Only 300 bottles were made in 2024.

● SAVIGNY-LÈS-BEAUNE CLOS DES GODEAUX

2024 ★ 🍃

Planted in 1968, Clos des Godeaux comes from 1.61 hectares of south-facing vines, at around 300m elevation. Jean poured this saying, "it has more in common with 2022 than 2023." Aromas of roses and peonies, with fabulous purity. The palate is zesty, with pretty orange rind flavours delineating the bright red cherry and berry fruit. 100% destemmed. One light pump-over per day, with one punch-down at the end of fermentation. Aged in barrel (no new oak) for around 10 months, followed by 4–5 months in stainless steel, which tightens the flavours and increases the reductive bite. Love this. Bottled in November 2025.

● SAVIGNY-LÈS-BEAUNE LES FOLLETES

2024 ★ 🍃

This comes from four plots in Savigny: Petits Picotins (55%), Grand Picotins (5-10%), Aux Fourches (30-35%), Saucours (5%). 0.78 hectares, planted between 1960 and 1979. In a sense, Les Follettes sits in the middle of the other two reds. Tasted from barrel in July 2025. Peppery and finely spiced, with aromas of iodine and grilled meats, opening onto a palate of dark, ripe berries lifted by fresh acids and supported by fine tannins. 50% whole-bunch fermentation. 20% new oak. 12.5% abv. This will be bottled in November 2025.

2024 is the third vintage of Les Lavières, the domaine's only *premier cru* (so far). This 0.8-hectare holding is close to Serpentières. The 100% whole-bunch fermentation introduces an element of soaring exotic spices to the dark berry aromas. The palate is fresh and upbeat, the sweet raspberry and wild strawberry fruit framed by fine, crunchy tannins. Again, that line of brisk 2024 acidity makes for a clipped, bright, sustaining thread. 10% new oak. Bottled unfiltered in November 2025.

POMMARD

A sibling to neighbouring Volnay, the red wines of Pommard are rich, age-worthy and deep in colour.

The complex soils are iron-rich, revealing a reddish hue, and contributing to brooding aromatics and tannic structure in the wines.

As early as the Middle Ages, Pommard was considered a wine to which all other Burgundian wines were compared. Now, it is arguably underrated. There are exciting wines to be discovered here.

DOMAINE CYROT-BUTHIAU

Brothers Marc-Emmanuel and Olivier Cyrot are the fourth winemaking generation of this family domaine. They own six hectares of vines across Pommard, Volnay, Santenay and Maranges. The cellars of Domaine Cyrot-Buthiau are dug into the side of a rocky escarpment in Pommard, beside the *premier cru* Les Arvelets.

The family estate was established a century ago by Olivier and Marc-Emmanuel's great-grandfather, Paul-Joseph Cyrot, who learnt his craft as *régisseur* of the prestigious properties Château de Pommard and Clos de Tart. In the 1920s, Paul-Joseph acquired his first vines in Pommard, to which further parcels have been added over the generations.

● BOURGOGNE PINOT NOIR

2024 ★

Domaine Cyrot-Buthiau's Bourgogne Pinot Noir comes from various lower-lying sites in the village of Pommard. The soils here are deeper, composed of clay-rich marls. Brightly red fruited, with a crunchy red cherry vibrancy to the palate. Aged in old oak barrels.

The palate offers sweet raspberry and blackberry fruit, with a plush fruit coating to the tannins. As Marc Cyrot says, in Pommard, the finesse is seen at *premier cru* level. Aged in 25% new oak barrels.

DOMAINE MARQUIS D'ANGERVILLE

Once part-owned by the Dukes of Burgundy, this domaine lies at the very heart of Volnay and is entwined with the history and identity of the village. Guillaume d'Angerville, the current Marquis, took over following the death of his father, Jacques, in 2003. The d'Angerville Pinot Noir clones are unique, producing particularly small, intensely flavoured grapes. These are long-lived Volnays of the very highest quality.

The domaine has 16.5 hectares of vines. Of these, 12.9ha are *premier cru*, accounting for 12% of Volnay's total 110ha *premier cru* vineyard.

Guillaume has recently been joined by the next generation, his daughter Margot.

The 2024 vintage of Domaine Marquis d'Angerville will be released in **March 2026**.

DOMAINE MICHEL LAFARGE

A domaine that needs no introduction to Volnay fans. Biodynamic since 1996, this much-loved property is run by Frédéric and Chantal Lafarge, their daughters Clothilde and Éléonore, and their son Maxime-Henri.

Frédéric has been at the domaine since 1978, taking over fully following the death of his father, Michel Lafarge, in January 2020.

The Clos du Château des Ducs was bought in 1900 by Michel Lafarge's father. The first wines to be bottled at the domaine in 1934 included Clos des Chênes, the domaine's largest Volnay *premier cru* holding.

The 2024 vintage of Domaine Michel Lafarge will be released **later in 2026**.

DOMAINE GEORGES GLANTENAY

Siblings Sarah and Guillaume Glantenay took over from their father Pierre in the 2013 vintage. Guillaume makes the wines, whilst Sarah runs the sales and administration side.

Sat within the village of Volnay, this family-owned domaine encompasses eight hectares of vines spread over Volnay, Pommard and Chambolle-Musigny. Viticulture is *lutte raisonnée*. The soils are ploughed, whilst pesticides and herbicides are avoided.

Tracing its roots to the 17th century, the domaine was established by Pierre Glantenay who later entrusted it to his son, Georges. The Chambolle holdings were passed down from Sarah and Guillaume's grandmother. Today, representing the fifth generation, Sarah and Guillaume have recently acquired 0.2ha in Pommard Les Cras, which now goes into the Pommard *village* bottling.

For the 2024 vintage, the whites had 15 months' *élevage* and the reds had 18 months.

Corney & Barrow has been the domaine's exclusive UK agent since the 2022 vintage, having worked with the wines since the 2017 vintage.

● BOURGOGNE ALIGOTÉ VIEILLE VIGNE 2024 ★

Vieille Vigne singular as it's just one (tiny) vineyard. A 0.2-hectare plot of 59-year-old Aligoté Doré vines, planted at a density of 10,000 vines/ha. The plot is just on the other side of the Route Nationale, called En Juillet. This tends to be the last of the whites to be picked. A lovely crushed rock, silex nose, with a palate of wet stone minerality and lime rind. Guillaume describes it as "efficient" – it does exactly what you expect. Vinified in an old 1,200-litre tonneau and a smaller one.

● BOURGOGNE CÔTE D'OR BLANC LAMEROSES 2024 ★

Apple and pear fruit, with wet stone minerality and white flowers. The palate is juicy and vibrant, richer than the nose suggests. Easy in its own skin. Fermented in barrel and *foudre*, then aged on lees for 13 months.

Old school Meursault on the nose, with buttery richness when tasted in autumn 2025. The palate is leaner than expected, waxy and with a nice crunch to the mid-palate, finishing saline and focussed. This will benefit from time to meld. 75% new oak, with 15 months' ageing in 500-litre barrels.

After replanting it with Chardonnay, the first proper vintage was 2015. The nose is pleasingly unadorned, allowing the natural richness and aromatics to emerge. This is vibrant and saline on the palate, driving and with juicy acidity. Fermented and aged in 228- and 500-litre barrels, with 30% new oak – less than in the past.

● **BOURGOGNE CÔTE D'OR PINOT NOIR
MAISON DIEU**

2024 ★

Around two-thirds Volnay and one-third Pommard, the domaine's Bourgogne Rouge is a blend of 10 different vineyards. Bright raspberry and red cherry aromas. The palate is crunchy and pure, with a tapered, salty finish. This spends one month in stainless steel, then is racked into barrels. No new oak. Bottled in December 2025. 12.8% abv.

● **VOLNAY**

2024 ★

This is made from eight different plots throughout the village. Together with the Vieilles Vignes (the next wine), there are 2ha of *village* Volnay at the domaine. The vines range from six to 60 years old. Wild strawberry and blackcurrant aromas. The palate is darker and more foresty than usual, offering *sous bois* and mushroom flavours. There is a small proportion of whole bunches for the first time this year. 20% new oak builds the body and adds a little cedar spice. A serious Volnay, which finishes salty and precise.

● **VOLNAY VIEILLES VIGNES**

This is a selection of the oldest vines, ranging from 65 to 93 years of age, from four plots of the domaine's two hectares of *village* Volnay: Les Buttes, La Gigotte, Les Combès and Les Petits Gamets. There are smaller grapes here, due to the old vines. Dark berries and bitter cherry on the nose. The palate is crunchy and bright on the attack, opening onto supple aromas of wild strawberry and spices, framed by fruit-coated tannins. 25% whole-bunch fermentation. 20% new oak. Only four barrels were made in 2024.

● **VOLNAY 1ER CRU LE RONCERET**

2024 ★

This is a stony 0.4-hectare plot of 65-year-old vines in the centre of the village, just below Champans. Half of the vines have recently come back into production. The first vintage was 2017. The name is thought to come from *ronce*, meaning blackberry. Ronceret is perhaps the most accessible of the premiers crus and tends to be one of the first vineyards picked. Fruity and aromatic – a nose of red berries and roses. The lacy palate allows the joyfully expressive raspberry fruit in full rein. Seven barrels were made in 2024, of the usual eight. 30% new oak. 100% destemmed.

● **VOLNAY 1ER CRU LA ROBARDELLE**

Adjacent to Santenots, the domaine's 0.35 hectare holding in La Robardelle is planted north-south, meaning the vines get sun exposure all day long when sufficiently de-leafed. 2024 is the fourth vintage of this wine, which had been leased by Sarah and Guillaume's parents. Robardelle has deeper clay soils, contributing to what Sarah describes as this wine's 'unctuous' character. Fresh mint on the nose with white pepper. The palate is sappy and saline, framed by intricate, lattice-like tannins. This will need more patience than Ronceret. 30% new oak, with a small amount of whole-bunch fermentation.

The vines were planted in 1948 and 1950. It is on the Pommard side of the village, to the north of Mitans and over the road from Les Angles. Black cherry, whole-bunch spices and fresh mint on the nose. The palate is powerful and assertive, offering dark berries framed by finely structured tannins. 50% new oak – the highest at the domaine. Eight barrels were made, versus 15-17 in a good year.

● VOLNAY 1ER CRU LES SANTENOTS
2024 ★

The domaine has 0.30 hectares in Les Santenots Dessous, the most clay-heavy part of the vineyard, on the Volnay-Meursault border. The majority of these vines are over 60 years old, with a smaller section planted in 2010. The deep clay soils make for a generous style of wine. Raspberry compote and pretty exotic spices on the nose. The palate is sweetly red-fruited, pliant and expansive, with very fine, chalky, quite powerful tannins supporting. Patience required here. 30% new oak.

**● POMMARD 1ER CRU

The premier cru Combes Dessus is on the border of Pommard and Volnay. The domaine has 0.3 hectares here. This was one of the first *cuvées* reintroduced to the domaine in 2015 by Sarah and Guillaume. Pure, bright raspberry aromas with cacao and fresh mint. The palate opens with wonderfully expressive wild strawberry and juicy acidity, framed by a fine lattice of tannins. Very elegant. A third new oak – three barrels, of which one is new.

This *village cuvée* is from three sites dotted throughout the village, offering an overview of Chambolle: Les Condemnnes, Les Creux Baissants and Les Fremières. Pretty raspberry aromas, pure and soaring. The palate is crystalline, with rose petal spices and a little white pepper, framed by perfume-infused tannins. 20% new oak. I made a note to myself to buy this, but I will have to be quick: just three barrels were made, versus 7-8 in a normal year.



DOMAINE JACQUES PRIEUR

Domaine Jacques Prieur calls Meursault home, although its holdings comprise a roll call of great names stretching the length of both côtes. The late Jean-Pierre Labruyère acquired a majority share in the domaine from the Prieur family in 1988, and winemaker Nadine Gublin was appointed in 1990.


In 2008, Jean-Pierre Labruyère's son Édouard took over management of the domaine, as well as the other family estates. These include the original family estate, Domaine Labruyère in Moulin-à-Vent, Château Rouget in Pomerol and, since 2012, Champagne J.M. Labruyère in Verzenay.

The domaine suffered significant crop losses of Pinot Noir in 2024: 90% in the Côte de Nuits and 50% in the Côte de Beaune. Being certified organic added to the challenges of the vintage as the team were unable to combat against mildew. However, the fruit that survived was pristine, resulting in the DJP reds being amongst some of our top scoring wines of the vintage. Chardonnay was largely unaffected and proved a great success.

Corney & Barrow has been the domaine's exclusive UK agent since the 2013 vintage and in Hong Kong since 2022.

The 2024 vintage of Domaine Jacques Prieur will be released in **later in 2026**.

DOMAINE MATROT

Domaine Matrot is a 24-hectare family-owned estate based in the centre of Meursault. Sisters Adèle and Elsa Matrot took over from their father, Thierry Matrot, in the 2016 vintage. Thierry had made the wines here for over three decades alongside the *Chef de Cave*, Gaël Fouré, who has run the cellar at the domaine for nearly as long.

With a history spanning six generations, the story of Domaine Matrot began with Simon Boillot, a winegrower in Meursault during the 1800s. His son, Claude Matrot, became a wine merchant who was captivated by the thought of owning his own vines and so in 1900, he purchased three *premiers crus* parcels on behalf of his family.

Each generation thereafter helped nurture the estate and acquire additional plots of vines – expanding from Meursault to incorporate Auxey-Duresses and Bourgogne Pinot Noir. Elsa joined her parents at the domaine in 2008, followed by Adèle in 2010.

● BOURGOGNE CHARDONNAY

2024

The core of this wine is from Meursault, where the domaine has four hectares. The rest comes from the family's two hectares in the Hautes-Côtes de Beaune, near Maranges, with 10% from Chablis. Bright and focussed, this is a crisp, energetic wine of white flowers and crunchy apple. Fermented and aged in barrel, with 20% new oak. No *bâtonnage*. Bottled just before harvest.

● **PULIGNY-MONTRACHET 1ER CRU CHALUMEAUX**
2024

This is a cooler terroir, with greater elevation, below Blagny, on the border of Puligny and Meursault. Fine white flowers, apple skin and white peach aromas. The palate is crunchy and taut, with lime rind and green apple skin on the entry, opening onto fleshier stone fruits. Great texture and bite on the back palate, finishing tactile and fresh.



● **MEURSAULT ROUGE**

DOMAINE PATRICK JAVILLIER

Family-owned Domaine Patrick Javillier is based in the heart of Meursault. Marion Javillier, daughter of Patrick, now runs the domaine, having gradually taken over from her father. The domaine owns parcels in Meursault, Puligny-Montrachet, Savigny-lès-Beaune, Aloxe-Corton and Pernand-Vergelesses.

After the war ended in 1945, Raymond Javillier decided to cultivate the two hectares of family vines. It wasn't until 1974 that the domaine really began to thrive, when Patrick took the reins from his father. During the 1980s and early 1990s, Patrick expanded the estate to its current ten hectares by acquiring new plots and with land from his wife's family.

In 2005, Marion joined her father and became responsible for the domaine's sales and red winemaking. In 2011, her brother-in-law, Pierre-Emmanuel Lamy, also joined the domaine, working in the vines and making the white wines. Together they represent the third generation.

The 2024 wines will undergo course filtration before they are bottled between November 2025 and February 2026.

● BOURGOGNE CÔTE D'OR CUVÉE DES FORGETS

2024

Named after the Rue des Forges, where the domaine is based, this comes from a number of parcels on the Volnay side of Meursault, on clay-rich soils which deliver density. Fleshy white peach fruit, finding some yellow hued richness on the mid-palate, with good purity, stony minerality and juicy, poised acidity. Around 20% new oak. This is the largest production wine at the estate — around 20,000 bottles have been made, which is about average.

DOMAINE PIERRE MOREY

Anne Morey, with support from her father Pierre, has taken the domaine into its second half-century in fine form. They have been joined from the 2020 vintage by the third generation, Anne's son, Jean-Victor Morey.

Our relationship with Pierre Morey dates back to his 20-year tenure as *régisseur* of Domaine Leflaive, from 1988 to 2008. The 'Morey era' includes some bucket-list Leflaive vintages. Pierre combined his position in Puligny-Montrachet with running the family estate in Meursault. Understandably, certain milestones were reached concurrently at both domaines, such as turning biodynamic in 1997.

Domaine Pierre Morey's 10 hectares span the villages of Monthélie, Pommard, Puligny-Montrachet and Meursault, where the domaine is based. In addition, the family has access to some choice parcels, which are vinified identically at the domaine and bottled under the *négociant* label, Maison Morey-Blanc, established in 1992. Around half the production here is Chardonnay with the remainder being Aligoté and Pinot Noir.

● BOURGOGNE ALIGOTÉ

This old vine Aligoté is from a 1.86-hectare plot of vines in Meursault, planted in 1969 and owned by the domaine. Lime zest and green apple skin on the nose. The palate is stony-mineral and grapey, with fine, crunchy orchard fruit flavours making for an Aligoté of freshness and approachability.

Perrières is an icon of the domaine, producing concentrated wines of substance. A third was replanted in 2012.

PULIGNY-MONTRACHET

Universally recognised, Puligny-Montrachet is often considered the pinnacle of white Burgundy. Situated at the southern tip of the Côte de Beaune, its wines offer a combination of steely precision and great depth of flavour.

It wasn't until 1879 that Puligny hyphenated the name of its most famous vineyard, Le Montrachet, which is split with its neighbour Chassagne.

Puligny-Montrachet boasts four *grands crus*: Chevalier-Montrachet and Bienvenues-Bâtard-Montrachet in their entirety, while Le Montrachet and Bâtard-Montrachet are shared with Chassagne. In addition, the appellation comprises around 13 *premiers crus*, further subdivided into numerous *climats*. Together with a range of village wines, Puligny-Montrachet covers a broad range of styles and prices.

Although famed for its white wines, there is also a small amount of Pinot Noir planted in the hamlet of Blagny — a *premier cru* for reds.

DOMAINE LEFLAIVE

Domaine Leflaive traces its history back to 1717, but it is said that Joseph Leflaive (1870-1953) is the true founder of this illustrious estate. Moreover, recent history owes a tremendous debt to his granddaughter, Anne-Claude Leflaive, who was manager from 1990 until her untimely death in 2015. Brice de La Morandière (great-grandson of Joseph) has been the domaine's managing director ever since. Domaine Leflaive is a standard bearer for biodynamics.

Based in Puligny-Montrachet, the domaine is one of the absolute benchmarks of fine white Burgundy. It has, since Brice's arrival in 2015, moved up to another level. Technical Diam corks have been used since 2014, the cellars have been renovated and the handling of grapes and wines rethought. 2022 was the first vintage made in the domaine's pristine new cuverie, which has further enhanced their ability to fine-tune every aspect of the process.

Corney & Barrow is the exclusive agent in the UK and Singapore. The 2024 vintage of Domaine Leflaive was [released in December 2025](#).



ESPRIT LEFLAIVE

Esprit Leflaive sees the Leflaive family push beyond the borders of Puligny-Montrachet and the Mâconnais, into the Côte de Nuits and beyond. It also sees the first Leflaive reds.

This new project, although intrinsically linked to Domaine Leflaive, needed its own identity with a nod to its roots – wine made in the 'spirit of Leflaive'. Grapes are sourced from a core of trusted vigneron partners. Although Leflaive is no stranger to innovation, it's the highly personal nature of this project that sets Esprit Leflaive apart.

Another point of difference is that these wines are not released *en primeur*, but in bottle once they have had time to develop.

The [2021 vintage of Esprit Leflaive](#) is now available to purchase. The 2022 & 2023 vintages will be released in early summer 2026.

DOMAINE FRANÇOIS CARILLON

François Carillon is the 16th generation of a winemaking family which traces its Burgundian roots back to 1520. Since his first vintage in 2010, François has proven his domaine to be both a worthy successor to the much-loved wines of his father, Louis Carillon, as well as making some of the most exciting modern white Burgundies.

Following the retirement of Louis Carillon, the vineyards were divided between the two sons, François and his brother Jacques. Domaine François Carillon sits in the very centre of the village of Puligny-Montrachet. The wines hit the sweet spot between pristine fruit, precise acidity and textural richness, which we adore.

François' sons Mathis and Paul have recently joined the domaine full time. The future is looking particularly rosy here.

The 2024s were harvested earlier than usual, in the first two weeks of September by a team of 50 pickers. The grapes were immediately pressed on reception, and the juice was left in tank to cool prior to fermentation. The majority of barrels used are 350-litre capacity. Always looking to expand his horizons, François has also produced a Beaujolais Blanc this year.

● LA BERGERIE CHARDONNAY

La Bergerie is the name of the principal parcel of this blend from Montagnac, near Nîmes. This is a selection from 20ha, made up of several parcels. Over the four years it has been made by François, it has become a firm favourite among C&B customers, offering a taste of the south with the domaine's *élèvage*. It is made at the domaine in Puligny-Montrachet, meaning it is a Vin de France rather than a Costières de Nîmes. Bright orchard fruit – apple and pear skin – with great purity. This is picked 7-10 days earlier than the Puligny vines. 13% abv. 15 months of *élèvage*, with bottling around Christmas 2026. 15-20% new oak.

This newer entrant into the Carillon line-up comes from southeast-facing vines in the village of Mâcon-Igé, where Domaines Leflaive also makes a wine. The appellation covers over 57ha for Chardonnay and is one of the emerging quality villages of the Mâconnais. OLIVIER LEFLAIVE

Olivier Leflaive needs little introduction to Burgundy lovers. Since its beginnings in 1984, this discreet house has carved out an enviable reputation, garnering impressive critical acclaim and a loyal following all over the world.

The signature style is inviting, geared for pleasure yet with the emphasis on freshness, structural clarity and the precise imprint of origin. This achievement is all the more remarkable for Olivier Leflaive's kaleidoscopic range of wines, one that spans so many of Burgundy's sub-regions, villages and lieux-dits.

Olivier's much-loved Technical Director Franck Grux retired at the end of 2023, after a long and distinguished career. His position has been filled by one of Burgundy's rising winemaking talents, Solène Panigai. Chosen by Franck himself as his successor, Solène worked alongside him for 18 months before finally taking the reins from the 2023 vintage. The house has always produced quality red wines alongside their legendary whites.

However, recent years have seen a growing focus on the quality and style of the red wines, which are now vinified in their own dedicated chai. We are delighted to be featuring two reds in this offer.

● MEURSAULT CLOS DE LA VELLE

2024

A monopole vineyard with 45-year-old vines, Clos de la Velle gives a classic Meursault with curves in all the right places, though never in excess. 2024 produced a crop of small, neat berries, yielding a Meursault of surprising focus. The profile is all there – ripe baked apples and poached pears spiked with nutmeg, the creamy midpalate and whisper of brown butter. Yet there is also a sense of freshness and sapidity, giving elegance. Structured and complete, with a lovely mineral taper and sense of chalk – a grown-up Meursault. A small number of magnums are also available this year, bottled specially for us.

There is a lovely latent fleshiness to the fruit, while notes of fresh white nuts, citrus oil and savoury miso add dimension, underscored by the sensation of fresh chalk.

SAINT-AUBIN

Nestled in the hills above Puligny-Montrachet and Chassagne-Montrachet, the core of Saint-Aubin is dominated by *premiers crus* sites. With various steep slopes and altitudes of over 300 metres above sea level, the *terroir* here is suitable for both red and white production.

The soils are clay-heavy, with white grapes preferring those with higher limestone content and the red grapes thriving on heavier brown clay.

Although often overlooked for its more famous neighbours, Saint-Aubin is a gem which, at its best, can rival them.



DOMAINE HUBERT LAMY

You could say that Domaine Hubert Lamy put Saint-Aubin on the map. We were delighted to add these brilliant wines to our roster during the small 2016 vintage. The domaine has 18.5 hectares of vines, 80% Chardonnay and 20% Pinot Noir. Beyond Saint-Aubin, it has holdings in Puligny-Montrachet, Chassagne-Montrachet and Santenay.

The Lamy family has been making wine in Saint-Aubin since 1640, however, it was not until 1973 that Hubert Lamy established the domaine. At that time, the estate consisted of around eight hectares of vines, with several new plots being added during the 1990s.

Olivier Lamy, son of Hubert, joined the domaine in 1995 and over the past three decades has taken the wines to new heights.

The wines are released once bottled meaning the 2023 vintage will be released **later in 2026**.

SANTENAY

Lying at the southern end of the Côte de Beaune, Santenay has an impressive history dating back to pre-Roman times. The village was prized for its thermal waters, rich in mineral salts. Also of historical significance is the Sorine windmill, which sits in the *premier cru* Beauregard vineyard.

Plantings here consist of around 90% red grapes and just 10% white. Greyish limestone occupies the higher vineyards, sitting at 500 metres, while the lower vineyards consist of marl and oolitic limestones.

DOMAINE JUSTIN GIRARDIN

Domaine Justin Girardin is a 17-hectare family domaine in Santenay. 13 of those 17 hectares are in Santenay itself, with the remainder further north, including in Pommard. We have worked with Justin since his first solo vintage in 2015.

Of the three premiers crus Santenays, Clos Rousseau has the greatest ageing potential and substance, whilst Beauregard is approachable in youth and Maladière, a C&B UK exclusivity, brings together aspects of both. Reds are 100% destemmed, accentuating the domaine's silky and pure-fruited style.

Winemaking includes around a week of pre-fermentation cold soak to extract aroma, with three pump-overs at the beginning of vinification and four days of post-fermentation maceration at 27°C. After this, the wines have a year's lees contact in barrel, with no racking until bottling.

Due to mildew and oidium pressure, yields were down in 2024; the domaine suffered a 30% loss on the reds and a 10-15% reduction on the whites.

● SANTENAY 1ER CRU BEAUREGARD

2024

This is a 0.92ha holding in Beauregard, the vineyard with the distinctive windmill, which is the highest of the domaine's Santenay holdings, around 50 metres above the others. The vines are 30-70 years old. These are poor soils, yet the wines tend to be the most approachable in youth. Aromas of violets and bitter cherries, leading into a pure palate of crunchy raspberry and blackberry, sustained by taut acidity. The tannins are fine, exerting a gentle grip on the finish when tasted in July 2025. 12-15% new oak. This will be bottled in late winter/early spring.

The name Maladière comes from the nearby Maladière of Chagny hospital. This is a sunny, warm, southeast-facing vineyard, with deeper soils, in the centre of the appellation. Justin has 0.7 hectares here. The vines average 60 years old. Dark cherry and berry fruit, with orange rind and a citric twist to the palate that, along with the bright acidity, makes for an upbeat style. This will be approachable young but has enough matter to age gracefully for 5-10 years. 12% new oak, with a higher proportion of one-year-old barrels this year (around a third of the total). This will be bottled in late winter/early spring. Lovely wine.

Clos Rousseau has deep, heavy clay soils. Justin's vines here have correspondingly deep root networks, allowing them to retain more water and conferring an age-worthiness on the resulting wines. The domaine has almost one hectare here, over four parcels, the youngest of which was planted in 2015, the others being 45, 60 and 65 years old. Dark cherries and raspberries, with clementine rind and a zesty, lemony lift. Again, the acidity is especially bright here, making for a lively, focussed style, framed by fine tannins. Less new oak this year: 12-15%, with more one-year-old barrels than usual.



● POMMARD LES VIGNOTS

2024

Justin has 0.35ha in what is considered to be one of the best village-level vineyards in Pommard, spread over two plots. This is the highest elevation site of the estate. The average vine age is 35-40 years. Aromas of cassis, bitter chocolate and fine cedar, leading into a palate of fleshy, pliant dark berry fruit. This is luminous and light on its feet – lots of flavour packed into a delicate chassis, very impressive. 20% new oak: five barrels were made, one of which was new.

CÔTE CHALONNAISE

Sitting directly south of the Côte de Beaune and above the Mâconnais, the Côte Chalonnaise produces both reds and whites.

Its undulating landscape offers a mixture of limestone, gravels and clay soils similar to that of the Côte de Beaune. The landscape here is less rugged than the Côte d'Or, and vineyards are broken up by other forms of agricultural farming.

There are five village appellations: Mercurey and Givry produce mostly red wine with small quantities of white, Montagny is solely white. Rully offers both red and white along with some sparkling wine and Bouzeron, uniquely, has its own appellation for white, exclusively made from Aligoté.

DOMAINE DE VILLAINÉ

Domaine de Villaine is co-owned by Pamela and Aubert de Villaine and their nephew, Pierre de Benoist, who has managed the domaine for over 20 years.

The domaine has two bases: the original estate buildings in Bouzeron, which were bought by Pamela and Aubert de Villaine in 1971 and, as of 2017, a property in Rully. The latter had been known since the 19th century as Domaine Saint-Michel. Pierre de Benoist had in fact made the wines here in the 2004 and 2005 vintages.

The domaine's six single-vineyard Rully *premiers crus* Chardonnays are offered a year behind the other wines. These wines are therefore from the **2023 vintage**.

The Bouzeron holdings include some 150-year-old Aligoté vines. The domaine also has parcels in neighbouring Mercurey. Domaine de Villaine's total holdings extend to 29.33 hectares. The estate has been managed organically since 1986 and certified organic since 1997. The wines are vinified in barrel and large oak *foudres*, with barely any new oak. These wines, along with the Rully Les Saint-Jacques, are from the 2024 vintage.

● BOUZERON BOURGOGNE ALIGOTÉ

2024 ★ 🌙 🌱

Bouzeron is the sole Aligoté-only appellation and a heartland for this grape. Domaine de Villaine has been key in putting the place and the variety on the map. The domaine's 17 parcels of Aligoté Doré vines cover nine hectares of the domaine's total 30. Green apple skin aromas with lime zest and blanched almond. The palate opens fresh and precise, finding a citric poise and tension on the mid-palate. The natural acidity of Aligoté cleanses the finish, which is salty and tapered. Bottled just before harvest, in August 2025. This will spend 10-12 months in old oak *foudres*, the volume of each tailored to the individual plots. 48,000 bottles in 2024, versus 60-70,000 bottles usually.

● RULLY 1ER CRU MONTPALAIS

The domaine's Montpalais, made since 2016, is not quite 0.4 hectares and is planted with 10-15-year-old vines. There is 12% Chardonnay Muscaté here, a clone with a floral, exotic edge, bringing a little aromatic flair. Montpalais is "the exact opposite of Grésigny", according to Pierre, who says that this is where the warmer northern part of Rully meets the cooler south. Brighter and more aromatic on the nose, with cedar spice. The palate is supple and inviting, a fresh line of acidity bringing a certain rigour to the flamboyant fruit. 5% new oak.

Aged in a combination of barrels and demi-muids.



Lying between Beaujolais to the south and the Côte Chalonnaise to the north, the Mâconnais benefits from more sun, less rain and less frost risk. The terrain alternates between hilly panoramas and tremendous cliffs, interspersed with farmland.

Sitting on the River Saône, it's an important Burgundian district offering dynamic wines. The production is swayed towards white wine, with 80% of the region being planted with Chardonnay, whilst the reds are largely dominated by Gamay.

The quality hierarchy begins with Mâcon, goes up to Mâcon-Villages and the top status is reserved for wines that hail from 26 specified communes, which can hyphenate their village name after Mâcon. The latter two levels are reserved for white wine only.



DOMAINES LEFLAIVE

Domaines Leflaine (with an 's') is Domaine Leflaine's operation in the Mâconnais. The estate's first vintage here, of Mâcon-Verzé, was in 2004.

The original holdings totalled 9.3 hectares, consisting of five plots: Les Chênes, En Perret, Le Monté, Escolles and Les Muses. Les Chênes and Le Monté are now produced as single vineyard cuvées, alongside a new wine from Mâcon-Igé, the village to the immediate north, and a Mâcon-Solutré.

● MÂCON-VERZÉ

From this original 14.65-hectare plot was spawned the single vineyard wines detailed below. You might reasonably think that this would leave the straight Mâcon-Verzé as something of a stripped carcass, but in many ways, it is the most complete wine here with a lush but restrained golden fruit perfume, clean, zesty, joyous. The palate is silken-fresh with a nice, almost chewy weight, but lovely tension and sweet length. A triumph in 2024.

In the southernmost part of Burgundy, Beaujolais is home to the Gamay grape. Although traditionally associated with light and fruity reds as popularised by Beaujolais Nouveau, the area has seen an increasing move toward site specificity and ageing potential.

The region covers a vast area of land, encompassing 13,500 hectares of vines. Within this are 12 appellations producing a range of styles from simple and fruity reds, to nuanced and complex styles with great ageing potential. Beaujolais comprises 300 different soil types with multiple heights and exposures. The south typically enjoys clay and chalk soils on a series of rolling hills, whilst the north boasts sand and granite.

There are 10 delineated areas known as *crus*, identified for the specific high-quality terroirs. The most renowned of these include Fleurie, Moulin-à-Vent and Morgon.

MOULIN-À-VENT

DOMAINE LABRUYÈRE

Domaine Labruyère is the oldest estate in Moulin-à-Vent, Beaujolais. Dating back to 1850, the original 10 hectares have been added to over the years. The most significant acquisition was of Le Clos du Moulin-à-Vent, the appellation's only *monopole*, situated beside the iconic windmill.

Since 2008, the property has been run by Édouard Labruyère, the seventh generation. Édouard grew up at the domaine and now works alongside winemaker Nadine Gublin and cellar master Michel Rovere.

In years of full production (unlike 2024), four wines make up the core of the range: Coeur de Terroirs, Champ de Cour, Le Carquelin and Le Clos du Moulin-à-Vent.

● MOULIN-À-VENT COEUR DE TERROIRS

Coeur de Terroirs offers an overview of the appellation and its granite soils. Due to this year's tiny volumes, in addition to the usual four parcels in Moulin-à-Vent, it includes the fruit from Carquelin and Champ de Cour, both of which are usually bottled separately. A supercharged Coeur de Terroirs, therefore. Brightly Gamay-fruited raspberry and strawberry aromas. The palate is buoyant and fruity, bright and expansive, with sappy spices. A joyful wine. 12.7% abv, with no chaptalisation. It will be bottled in March 2026 – a little earlier than usual – Nadine choosing to bottle it "on the fruit". All destemmed, with maturation in old 600-litre *demi-muids*.

● LE CLOS DU MOULIN-À-VENT MONOPOLE

The domaine's top wine, Le Clos, which sits beside the iconic windmill, is the only *monopole* in Moulin-à-Vent. It is a 0.92-hectare south-facing walled vineyard, planted with over-70-year-old untrellised vines. Arid soils of sand and rock sit above hard granite. This was tighter aromatically when tasted in November 2025, with a clenched, tautly wound palate of sweet dark berry fruit, framed by ferrous tannins and with spicy flair on the end of the palate. The finish is salty and fine. A visceral wine which showcases its terroir beautifully. 100% destemmed, with ageing in 228-litre oak barrels. The yield was just 6hl/ha – as Édouard Labruyère said, "it's Sauternes".

WHAT IS EN PRIMEUR?

A traditional pre-ordering system of fine wines that originated in Bordeaux, *en primeur* translates as 'the first' referring to wines being available to purchase at first release prices. These wines are typically still in barrel at the point of purchase and not bottled and shipped to the UK until a year or more later. The first release price excludes duty and VAT, which are payable at the prevailing rates upon release from our bonded warehouse.

WHAT IS A BONDED WAREHOUSE?

A government-approved secure facility where wines are received in the UK and stored without immediate payment of customs duties or VAT. The wine arrives at a specific customs-controlled area of the warehouse under strict security and inventory controls. Wines stored here are considered in transit until the duties are settled. Corney & Barrow has its own bonded warehousing where all wines bought *en primeur* are stored upon arrival in the UK. Only when the wines are released from the bonded warehouse (for example, delivered to a customer's residence) is the duty and VAT payable.

WHEN SHOULD I EXPECT SHIPMENT?

Shipment of the wines in this offer to our bonded warehouse will take place between February 2026 and January 2027. For specific producer shipment dates, please enquire.

WHAT DO THE PRICES INCLUDE?

All prices in our Burgundy offer are quoted in bond by the case. This means the prices include shipping and insurance costs, but they exclude duty and VAT. Wines are only available for purchase by the case unless stated otherwise.

WHAT IS THE AVAILABILITY OF THE WINES OFFERED?

Quantities available vary depending on the wine, this is especially relevant given the 2024 crop was small in particular areas/ for certain producers. Stocks of certain wines will be allocated subject to demand. For further information on specific wines, please contact your C&B sales rep, or contact us at sales@corneyandbarrow.com.

WHAT ARE THE DELIVERY & STORAGE TERMS?

Once the domaine has bottled their wines, they will be shipped to our bonded warehouse in the UK. Upon receipt of the wines at our warehouse, you will be notified via email, and the wines will be listed on your reserves statement. You can elect to either keep the wines in our warehouse for a storage fee, have them moved to another storage facility, or delivered to your home. If you choose to remove the wines from our bonded warehouse, you will be required to pay duty and VAT at the prevailing rates. Delivery can be arranged via your C&B sales rep.

Certain offers are sold subject to specified storage terms. These terms are typically in relation to the rarest, allocated wines and are outlined in the individual offer at the time of release.

HOW DO I ORDER?

Please contact your C&B sales rep with a list of wines you would like to order, and they can confirm availability and offer further advice. If you don't already have a C&B sales rep, or you're unsure of who handles your account, please contact sales@corneyandbarrow.com. 
